Postdoctoral/Research Assignment "Chemical aging of biomass burning emissions in the atmosphere"**

The Institute of Chemical Engineering Sciences, Foundation of Research and Technology - Hellas, (FORTH/ICE-HT) is seeking applicants for postdoctoral/research assignment in the context of the research project "Pyrogenic Transformations Affecting Climate and Health (PYROTRACH)", which is implemented under the **EU-Horizon 2020 Research Framework Programme**.

**Job Description**

To conduct research in the framework of the aforementioned project "PYROTRACH". The main objective of PYROTRACH is quantify the evolution of biomass burning emissions in the atmosphere together with their impacts on human health and climate.

A PhD in Chemical or Environmental Engineering, Physics or Chemistry on atmospheric aerosols or atmospheric chemistry is preferred. Moreover, the candidates must be fluent in English, in order to meet working conditions. The evaluation of the candidacies will be based on the following criteria and qualifications:
